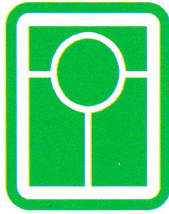
MISSION

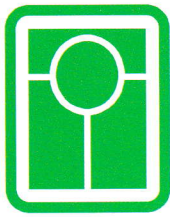

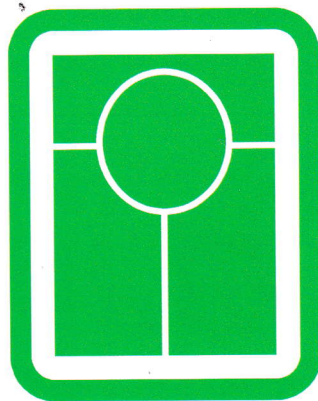
